3 Start date

4 Closing date

The closing date for this competition will be 21.03.2022.

5 Selection of the winner

- 5.1 A link to each approved video entry will be added to the Sound Performance website.
- 5.2 Entries will be judged on performance initially by Sound Performance Limited which will then shortlist twenty entries for review by a panel of 4 to 6 industry judges including a judge from Sound Performance. The final judging panel will be communicated prior to closing date of competition.
- 5.3 One winner will be selected from the shortlist.
- 5.4 The winner will be chosen from all entries correctly submitted in accordance with these terms and conditions.

- 6.1 The winning band or artist will receive: 500 x standard weight 7" Vinyl or 12" Vinyl in standard printed sleeve, lacquer cut and pressed free by Sound Performance Limited; and

- 6.4 The prizes do not include the finished artwork and/or master recording for the record which must be provided by the winner.
